Hartland Township Tax Bill Payments

For your convenience, Hartland Township now offers several options for making tax bill payments.

- Online through our website www.hartlandtwp.com
- Automatic Withdrawal- enrollment form can be found on our website (please submit by July 31 for September payment).
- Township Hall Dropbox- conveniently located both inside and outside.
- Mail- make checks payable to "Hartland Township" (do not send cash).
- Pay at the bank- Tax payments are accepted at the Hartland branch of First National Bank, located on M-59 in Hartland Township.

Hartland Home Values and Taxes

Home values are on the rise in our area. Over the past 10 years, we've seen a 73% increase in home market value.
