SPECIAL JOINT MEETING OF PLANNING COMMISSION WITH HARTLAND TOWNSHIP BOARD MAY 2, 2002

- 1. CALL TO ORDER The meeting was called to order by Chairman Fountain at 7:30 p.m.
- 2. PLEDGE OF ALLEGIANCE
- 3. ROLL CALL Secretary Kalenauskas called the roll. Members present: Chairman Fountain, Secretary Kalenauskas, Commissioner Petrucci, Commissioner Phillips, Commissioner Colaianne and Commissioner M. Germane. Absent: Vice Chairman Douglass. Also present: David Nicholson and Amy Neary of McKenna Associates.
- 4. APPROVAL OF MARCH 28, 2002 AGENDA Remove item #5 and add as item #10a. Mission Statement for Pleasant Valley / M59 Special Planning Area.

 Move to approve the March 28, 2002 Planning Commission agenda as amended. Motion Phillips. Second Petrucci. Voice Vote. Motion Carried. 6-0-1.
- **6.** CALL TO THE PUBLIC Jackie Scheller came forward but was advised that her item was on the agenda and she would be heard at that time.
- 6a. PUBLIC HEARING APPLICANT: SHOPS OF WALDENWOODS SITE PLAN APPLICATION #270 AMENDING THEIR PLANNED DEVELOPMENT AGREEMENT- Jeff Thompson of Aikens was present. He is seeking amendment to the PD agreement language to allow sign applicants to apply to the ZBA for a variance on sign size. Mr. Nicholson's letter of March 28, 2002 proposes draft language for a possible amendment. Chairman Fountain entertained questions or comments from the audience. There were none. Mr. Thompson will have his attorney prepare draft language and submit it to the Township. Commissioner Colaianne suggested, and Mr. Thompson agreed, to have language inserted into the PD agreement that signs would have to be removed in a certain time period if a business closes.
- 7. APPLICANT: INTERCITY NEON / SHOPS AT WALDENWOODS / HALLMARK SIGN APPLICATION #401 SECTION 21 Pat Blankenship was present. Commissioner M. Germane reviewed the sign. According to the ordinance, the sign exceeds the allowable square footage by 7 sq. ft. due to the size of the "H".

 Move to approve Sign Application #401 for Intercity Neon / Shops at Waldenwoods / Hallmark with the understanding that the sign size be reduced by 7 sq. ft. and the drawing be reviewed by Commissioner M. Germane prior to installation. Motion Phillips. Second Colaianne. Voice Vote. Motion Carried. 6-0-1.
- 8. APPLICANT: JACKIE SCHELLER SUBDIVISION PLAT APPLICANT #11 SECTION 23 TO SET A PUBLIC HEARING Move to set a public hearing for Subdivision Platt Application #11 for Jackie Scheller on April 11, 2002. Motion Phillips. Second Petrucci. Voice Vote. Motion Carried. 6-0-1.
- 9. APPLICANT: CARROLL INSTALLATIONS / SHOPS AT WALDENWOODS / GNC SIGN APPLICATION # 402 SECTION 21 Commissioner M. Germane reviewed the sign.

10a. MISSION STATEMENT – PLEASANT VALLEY / M59 SPECIAL PLANNING

AREA – The Commissioners discussed the draft dated March 4, 2002. It was the consensus of the Commission to change the "should" in goals #4 and #5 to "shall".

Delete "In designating and implementing a Special Planning Area" and insert "Consistent with this mission statement...".

Place on the April 11, 2002 agenda.

Move to table Mission Statement for Pleasant Valley / M59 Special Planning Area. Motion Kalenauskas. Second Colaianne. Voice Vote. Motion Carried. 6-0-1.

11. CALL TO THE PUBLIC – Commissioner Colaianne discussed some of the ideas of Peter Pollack for creative solutions to development issues.

12. COMMITTEE REPORTS –

M. Germane – In the March 14, 2002 minutes, the second signature at the end of the minutes should be D. Kalenauskas not Ann Ulrich.

Maintain consistency about observing the deadline for adding items to the agenda. Items should not be on the agenda if they are not complete.

The May 16 special meeting should be designated as sign discussion.

Construction at the Speedway station needs to be checked.

An overview of the Great Lakes document is available for review.

Small wetlands are unregulated and quickly disappearing.

Review the scope of work (3-18-02) from McKenna on the special planning area and be ready to act at the next meeting.

Visioning invitations will go out Friday, March 29, 2002.

There is a site plan review seminar in Grand Rapids that Commissioner M. Germane would like to attend.

Phillips – The letter concerning the Beauchamp site did not have any indication of who generated it.

The ordinances being considered by the Board were distributed for Commissioners to review.

Petrucci - Nothing.

Kalenauskas – Changeable copy, animated and time/temp signs can be combined in the ordinance. Drop the word "freestanding". A monument sign is the same as a ground sign. The sign ordinance wording needs to be cleaned up. Add a definition of a doubled faced sign.

Fountain – The trailer at the Oasis has fallen over and the site looks worse than ever. Commissioners should still be considering topics for the joint meeting with the Board.

There was discussion with Mr. Nicholson and Ms. Neary concerning the visioning sessions. The outline is: introduction, focus group discussion, list of maximum of ten topics of concern, each list reviewed for entire group and voting with dots as to the importance of issues listed.

There will be a registration table with name tags.
