- 1. ROLL CALL The meeting was called to order by Chairman Fountain at 7:30 p.m. Members present: Chairman Fountain, Vice Chairman Douglass, Secretary Kalenauskas and Commissioner Justin. Commissioner Germane arrived at 7:35 p.m. and Commissioner Phillips arrived at 7:45 p.m. Commissioner Petrucci was absent.
- 2. APPROVAL OF MARCH 22, 2001 AGENDA Move to approve the March 22, 2001 Planning Commission agenda as presented. Motion Kalenauskas. Second Justin. Voice Vote. Motion Carried. 4-0-3.
- 3. APPROVAL OF MARCH 15, 2001 MINUTES Move to approve the March 15, 2001 Planning Commission minutes as presented. Motion Douglass. Second Kalenauskas. Voice Vote. Motion Carried. 4-0-3.
- **4. CALL TO THE PUBLIC** Robert Bulloch of Dunham Road asked the status of the school application. The Chairman informed him it was on the next agenda. He also asked if the Superintendent of Schools could override Township decisions on the school application. The special use must go through Township review.

8. APPLICANT: ERIC PREISS SPECIAL USE APPLICATION #198 IN CONJUNCTION WITH SITE PLAN APPLICATION #304 MAJOR CHANGE TO SPECIAL USE APPLICATION #190 SECTION 06 - Mr. Preiss and Mr. Perry were present. Mr. Perry reviewed the changes made according to the reviews by Tetra Tech and McKenna which included contouring, gravel surface, added landscaping, correct impervious calculation and doubling the number of storage bins.

Ms. Neary reviewed the McKenna site plan letter dated February 28, 2001 including the metal light poles stored on sight, salt storage, covering materials to prevent blowing, plant materials specifications and performance guarantees. If lighting is planned, it must be shown in details and locations.

Ms. Neary also reviewed the McKenna letter of March 1, 2001 concerning the special use. Trailer parking will only be for the ones used by Mr. Preiss. No rental trailers permitted. The applicant agreed to make all bins 8 ft. high to help prevent blowing of materials. The topsoil pile will be eliminated and placed in bins. Mr. Perry noted that there is no pole mounted lighting planned.

Mr. Nicholson noted that the salt storage building was the proper design for this function.

Mr. Preiss has logs on the property to be cut into firewood but would remove them if so requested. The consensus of the Planning Commission was to have the logs gone in 90 days.

Mr. Douglass stated that the metal light pole being stored for MDOT were not part of the use allowed for the landscape nursery business.

Mr. Preiss agreed to have his hours of business set at 7a.m. to 6p.m.

Mr. Germane felt the expansion should be denied and remain as it had been previously approved.

Move to recommend denial of Special Use Application #198 in conjunction with Site Plan Application #304 for the following reasons:

- 1. The proposed use is not harmonious with the surrounding property per Sec. 33.07.F.
- 2. The materials listed for use within the special use are not compatible with a landscape nursery business.
- 3. The proposed use is potentially detrimental to the adjacent property.

Motion Germane. Second Douglass. Voice Vote. Motion Fails for lack of a majority. 3-3-1. Navs Justin, Fountain and Kalenauskas.

The applicant offered to remove the utility pole storage from the site plan.

Fountain - Too many signs are going up without permits. This needs to be tightened. A memo on roads was distributed. The crushed limestone is much more effective than gravel and should be used.

Move to retain Chairman Fountain, Vice Chairman Douglass and Secretary Kalenauskas in their positions from March Of 2001 through March of 2002.

An updated zoning map was distributed for Planning Commission review by Mr. Nicholson. The current map was never certified by the Township.

Mr. Kalenauskas summarized the situation with the William Carr property as of the ZBA meeting.

The Township Attorney should be consulted during the next review of the zoning map and masterplan. The masterplan should be done first then work on the Capital Improvement Plan.

Move to have a regular Planning Commission meeting on March 29, 2001 to discuss Hartland Schools. Motion Germane. Second Justin. Voice Vote. Motion Carried, 5-1-1. Nay Kalenauskas.

Douglass - The Clerk's letter on signs to identify proposed rezoning locations needs consideration. Mr. Nicholson suggested having the developer do the signs per the Township's specifications.

Move to set a special work session to discuss the schools at 7:00 p.m. March 28, 2001. Motion Germane. Second Justin. Voice Vote. Motion Carried. 6-0-1.

Germane - Need to eliminate multiple agendas. There are six colors in the Courtesy Communications sign. The Zoning Administrator will check.

Phillips - There is an April 26, 2001 seminar on signs in Mt. Pleasant.
