- 1. ROLL CALL The meeting was called to order by Chairman Fountain at 7:30 p.m. Members present: Chairman Fountain, Secretary Kalenauskas, Commissioner Phillips, Commissioner Kuhn, Commissioner Germane and Commissioner Petrucci. Commissioner Douglass arrived at 7:33 p.m. Also present: David Nicholson and Amy Neary of McKenna Associates and ZA Christensen. In the audience, Supervisor Bogdanski and Trustee Bulloch.
- 2. APPROVAL OF SEPTEMBER 14, 2000 AGENDA Add as item #8a SEMCOG Discussion of Sewer District.

Motion to approve the September 14, 2000 agenda as amended. Motion Phillips. Second Kuhn. Voice Vote. Motion Carried. 6-0-1.

- 3. APPROVAL OF SEPTEMBER 7, 2000 MINUTES Motion to approve the September 14, 2000 minutes as presented. Motion Kalenauskas. Second Kuhn. Voice Vote. Motion Carried. 6-0-1.
- 4. CALL TO THE PUBLIC There being no response, the call to the public was closed.
- 5. PUBLIC HEARING APPLICANT HARTLAND TOWNSHIP REZONING APPLICATION #285 REZONING FROM HSC TO GC SECTION 21 NORTH OF M59 Mr. Nicholson read his review letter of September 12, 2000 concerning allowable uses under GC zoning, surrounding zoning, consistent zoning and environmental concerns.

Matthew Quinn, attorney representing Oasis Investments LLC, was present. Mr. Quinn stated that his client had not received notice of the proposed zoning change and felt that the Township had made several technical omissions in the application process.

Mr. Christensen stated that Mr. Quinn's client had been notified by mail as required and notices had been posted in the paper of record.

Mr. Wyland gave his opinion that this issue should be researched to be sure everything was in order.

After discussion, the Planning Commission agreed to continue with the public hearing as planned. The Planning Commission usually makes no decision on the night of a public hearing. Mr. Quinn would have more time to study the situation. It was decided to recess the public hearing to the next regular Planning Commission meeting in two weeks. Mr. Quinn agreed to proceeding with the public hearing with no action taken tonight and recessing until the next regular meeting in two weeks.

Chairman Fountain called for comments and questions from the audience but there was no response. The public hearing was recessed at 7:58 p.m.

8. APPLICANT: BROWNIE'S SIGN COMPANY SIGN PERMIT APPLICATION #364 POLE SIGN SECTION 22 - Randall Lang and Lon Brown were present. The sign will be for Michigan Manufactured Home Monthly. Mr. Kuhn reviewed the application. Change the setback notation from "64 inches" to "64 ft.".

- **8a. SEMCOG PROPOSED SEWER DISTRICT -** Supervisor Bogdanski had received a request from SEMCOG for sewer projections through the year 2030.

- 9. CALL TO THE PUBLIC Mr. Bulloch was present to request a determination of a minor or major change to his sawmill building. Of the approved 160 foot building, only an 80 ft. building has been built. Rather than build another 80 ft. to the west of the current structure, he would like to build a 56 ft. addition to the east. The use will remain the same.

An overall Master Plan review will identify special study areas.

Mr. Fountain requested Mr. Nicholson bring in photographs of existing architectural features that he feels may be helpful in the work session discussion.
